



Training course Classification & Labelling of mixtures according to CLP

Background

Regulation EC 1272/ 2008 (CLP) is the EU implementation of the Globally Harmonised System and sets new requirements for the classification and labelling of chemical products (substances and mixtures).

Based on our experience with classifying mixtures and our background at the REACH & CLP helpdesk, we have developed a training course that:

- provides insight into REACH & CLP and new requirements
- learns to read SDS-es & ECHA databases
- learns to classify mixtures according to CLP for health & environmental hazards.



Goal: being able to classify mixtures for health & environmental hazards using calculation rules in CLP annex I and drafting CLP labels*.

For whom?

For anyone that has a task in classifying & labelling of mixtures (for supply or in-house)

CLP has other rules, exceptions and special situations that cannot all be discussed in a training. The training lays a foundation, participants will have to gain experience with what has been learned, information sources (regulation & guidances) and discussions with others.
